A RESOLUTION SUBMITTING  
A PUBLIC POLICY QUESTION TO  
INCREASE ROAD AND BRIDGE TAX RATE

HANCOCK COUNTY CLERK  
HANCOCK COUNTY, ILLINOIS

Section 1: Appanoose Township Road District is authorized to levy a road and bridge tax at a maximum rate of .165% of the value, as equalized or assessed by the Department of Revenue on the taxable real property in Appanoose Township Road District.

Section 2: Appanoose Township Road District has insufficient revenues to fund road and bridge purposes of the road district.

Section 3: Appanoose Township Road District may establish a road and bridge tax at a maximum rate of .33%, if a referendum is approved at a general election. 605 ILCS 5/6-501

Section 4: The corporate authorities (supervisor and township trustees) submit the following question of public policy to the voters Appanoose Township Road District:

PROPOSITION TO ESTABLISH .33% ROAD AND BRIDGE  
FUND RATE

“Shall the maximum allowable road and bridge tax rate for Appanoose Road District of Hancock County, State of Illinois, be increased from .165% to .33% of the Value of all taxable property within the Road District as equalized or assessed by the Department of Revenue?”

Section 5: The corporate authorities submit this question of public policy to the voters of Appanoose Township at the Consolidated Election to be held April 5, 2011.

Section 6: The Appanoose Township Clerk is directed to file a certified copy of this resolution with the Hancock County Clerk, Carthage, Illinois.

This resolution was approved by the corporate authorities of Appanoose Township at a meeting held on the 8th day of November, 2010.

Section 5: The corporate authorities submit this question of public policy to the voters of Appanoose Township at the Consolidated Election to be held April 5, 2011.

Section 6: The Appanoose Township Clerk is directed to file a certified copy of this resolution with the Hancock County Clerk, Carthage, Illinois.
