**ORDINANCE PROVIDING FOR A NON-BINDING PUBLIC POLICY REFERENDUM

**BE IT HEREBY ORDAINED** by the City Council of the City of Hamilton, Hancock County, Illinois, as follows:

**SECTION 1:** That there shall be submitted to the voters of the City of Hamilton at the primary election to be held on Tuesday, February 5, 2008, in said City of Hamilton, the following non-binding public policy proposition:
