NOTE: The entire reorganization process has been under section 11D of the School Code. It is further noted that the proposition to create a new high school district and new elementary school districts shall pass if a majority of voters in each of the affected districts vote in favor of the proposition. There will be three (3) districts involved in the referendum noted as follows: (A) Carthage Community Unit District No. 338; (B) Dallas Community Unit District No. 336; and, (C) La Harpe Community Unit District No. 335.
